That Ramakrishna Mission Vidyamandir, Katihar is run by Ramakrishna Mission Ashrama, Katihar which is a branch centre of the Ramakrishna Mission, P.O-Belur Math, P.S.-Bally, District-Howrah, West Bengal, a society registered under the Societies Registration Act.

That the Ramakrishna Mission is an organization of a non-proprietory character.

- 4. That there is a School Managing Committee to look after and manage the affairs of Ramakrishna Mission Vidyamandiy, Katihar. The members of the School Managing committee are not related to one another.
- 5. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
- 6. That no part of income from the school is being or will be diverted to any individual in the Society / the School Managing Committee or any other person / entity. The savings, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, depreciation Kanlesh Kr. Sharmand contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.

That the school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.

that the Principal and the Secretary of the School Managing Committee have individually gone through the provisions contained in the affiliation and examination by laws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation and examination by laws, directions issued from time to time and the law of the land.

- 9. That the school will ensure compliance of all statutory requirements like EPF, ESI and labour laws etc with regard to the school and the staff of the school.
- 10. That the school will ensure that the building safety, fire safety, water safety, health and hygiene certificates are being issued or renewed by the concerned Municipal or state authorities from time to time as per the prescribed forms.
- 11. That the school will ensure that the required infrastructure is available with it before starting classes.
- 12. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bylaws are available with the school before starting classes.
- 13. That the school will follow the provisions relating to fee contained in affiliation bylaws and will disclose the details of the fee to the students / parents every year before start of a session without resorting to any hidden charges in the heads of fee.

14. That the school will not coerce any student / parent to buy books / stationary / uniform from any particular shop.

15. That the school will make efforts for conservation of environment.
